PROGRAM INFORMATION



Thank you for your interest in our Associate Degree Nursing Program. The need for registered nurses in the community and nationwide has remained constant. Ssalaries for staff RNs in Florida average approximately \$84,760 depending upon education, experience, and location. The Gulf Coast State College Associate Degree Nursing Program is accredited by the Accreditation Commission for Education in Nursing, Inc.*

As identified in the packet and brochure, GCSC's registered nursing program is a **72-credit-hour** program that encompasses on-campus classroom and laboratory hours and clinical experience in a variety of local hospitals and facilities. Once selected, students should complete the full-time nursing program in two years. Required general education courses can be completed prior to program entry or during the program in compliance with the table demonstrated on the curriculum page in this packet. Upon graduation, students receive an Associate of Science Degree in Nursing (A.D.N.) and are eligible to sit for the national exam to obtain a Registered Nurse (R.N.) license.

An Associate in Science Degree in Nursing is the first step in professional nursing. Nurses may seek advanced education and additional certifications to progress in their profession with a Bachelor of Science Degree in Nursing (available here at GCSC or through university programs), a Registered Nurse First Assistant Advanced Technical Certificate (also available at GCSC), a Master's Degree in Nursing, or a Doctoral Degree.

Attached is the program information packet. It includes information you will need to read if you would like to begin the online application process. Current estimated expense sheets for the ADN program are available online by clicking on the cost sheet link at http://www.gulfcoast.edu/current-students/academic-divisions/health-sciences/nursing/registered-nursing/index.html. Applicants desiring admission into the RN program, who have failed to achieve a "C" or better or whose transcripts reveal withdrawals in **ANY** two nursing courses, in any registered nursing program(s) attended, will not be considered for admission. Students who have been readmitted one time to **ANY** RN program are not eligible for admission. Failure to disclose previous enrollment in a nursing program (or courses) may render the student ineligible for admission.

ADMISSION APPLICATION DEADLINES: Two classes are admitted each year, one in the spring and one in the fall. The deadlines for applications to be submitted with all checklist items completed are by the last working day in **FEBRUARY** (for fall class) and the last working day in **SEPTEMBER** (for spring class). Applications are held for one year after being received. If the applicant has not been assigned to a Nursing advisor by then, students will need to re-apply.

Associate Degree Nursing Program Tracks for Entering

ASSOCIATE DEGREE NURSING:

This program is for the student who enters without prior nursing core courses and intends to complete all the required nursing core courses at Gulf Coast State College. Only offered at the Panama City campus. (This option requires this packet).

ADVANCED PLACEMENT INTO THE ASSOCIATE DEGREE NURSING PROGRAM:

The program is for the student who has completed any portion of a Registered Nursing Program's core courses at another College or University and wishes to transfer credit into Gulf Coast State College's Associate Degree Nursing Program. Depending upon a transcript evaluation, the student may be allowed to enter the program with advanced placement if the coursework in nursing is less than two years old. The student must complete a minimum of <u>eighteen credit hours</u> at Gulf Coast State College to be eligible for graduation. (This option requires <u>this</u> packet as well as an additional checklist).

LPN to ADN ARTICULATION – TRADITIONAL OPTION:

The student is a Licensed Practical Nurse (LPN) and wishes to enter with advanced standing into the Associate Degree Nursing Program <u>Weekday</u> Option at Gulf Coast State College at the <u>Panama City</u> campus. Classes are full-time, Monday through Thursday. (This option requires a <u>different</u> application packet).

LPN to ADN ARTICULATION – WEEKEND OPTION:

The student is a Licensed Practical Nurse (LPN) and wishes to enter with advanced standing into the Associate Degree Nursing Program <u>Weekend</u> Option at the Gulf Coast State College <u>Gulf Franklin</u> campus. Classes are on Friday for 6 hours, and clinical meets on Saturday *OR* Sunday for 12¹/₂ hours. (This option requires a <u>different</u> application packet).

PROFESSIONAL LICENSURE DISCLOSURE

Gulf Coast State College Associate Degree Nursing Program is accredited by the Accreditation Commission for Education in Nursing, Inc. ASSOCIATE DEGREE NURSING CHECKLIST FOR ADMISSION TO THE ASSOCIATE DEGREE IN NURSING

NOTE: Students who have ever been admitted to any Registered Nursing Program previously must produce a Letter of Recommendation from the previous Nursing Dean / Director. A student whose transcripts reveal withdrawals or failures to achieve a "C" or better in **ANY** two nursing core courses, in any RN nursing program(s) attended, will not be considered for admission. Students who have been readmitted one time to **ANY** RN program are not eligible for admission.

Students should complete the following five checklist items as soon as possible to receive a permanent Nursing Advisor assignment.

1. APPLY FOR GENERAL ADMISSION TO THE COLLEGE Failure to declare the correct major can result in lengthy evaluation delays. Visit GCSC Enrollment Services in person or on the web at <u>www.gulfcoast.edu/admissions/</u> to obtain information on the college admissions process, including the College application fee.

Returning students who have not taken classes at GCSC in the last year must re-apply for admission.

While working on admission to this program, you may choose the Nursing Option, Liberal Arts A.A., as your major only if you intend to complete that separate degree either before or after this limited access program. To request a major change, visit <u>https://www.gulfcoast.edu/admissions/forms.html</u>. Students declaring an unintended major for the sole purpose of receiving financial aid may be subject to penalties, including repayment of any financial aid received. Some support courses listed in the General Nursing Option, Liberal Arts A.A. are not required for A.D.N. Program.

2. PROVIDE OFFICIAL HIGH SCHOOL, VOCATIONAL SCHOOL & COLLEGE TRANSCRIPTS

An <u>official</u> transcript is a transcript that is sent directly from the granting school/institution to **GCSC Enrollment Services**. Transcripts that have been in the student's possession (regardless of whether they are "sealed," stamped, or in a sealed envelope) are not considered official and will not be accepted. Transcripts must be submitted from ALL post-secondary educational colleges or universities attended and must display all periods of enrollment and/or degrees earned. The applicant is responsible for ensuring that all college transcripts are evaluated prior to the application deadline for which they are hoping to be chosen as an incoming program student. Evaluations can sometimes take weeks to be completed. Applicants should check their online GCSC academic transcript to see when the evaluation has been completed and to check courses for accuracy.

3. COMPLETE AND SUBMIT THE ASSOCIATE DEGREE NURSING APPLICATION ONLINE

Preferably at the *beginning* of your academic career, a current application should be completed and submitted online at https://www.gulfcoast.edu/academics/academic-division/nursing/registered-nursing/index.html.

4. OBTAIN A NURSING FACULTY ADVISOR (Students should reach this point as quickly as possible). <u>After ALL of the above criteria (items 1 thru 3) are met</u>, the student **MUST** contact the Academic Program Specialist to request a Nursing Faculty Advisor. The Academic Program Specialist can be reached at 850.913.3311 or <u>HealthSciencesGCSC@gulfcoast.edu</u>.

NOTE TO ALL STUDENTS: It is the RESPONSIBILITY of the STUDENT to MAINTAIN COMMUNICATION WITH the ACADEMIC PROGRAMS SPECIALIST and/or ADVISOR to ensure that their application folder is complete and up-to-date with current admission requirements. Check the Academic Programs Specialist and/or Advisor's schedule ~ Nursing faculty may not be on campus Tuesdays, Wednesdays, or Thursdays (due to clinical assignments) or during summer months.

To be considered for ADMISSION into the Nursing Program, the applicant's folder MUST BE COMPLETED WITH ALL CHECKLIST REQUIREMENTS BY THE APPLACATION DEADLINE DATES.

The applicant **MUST** contact his / her assigned Nursing Faculty Advisor to review the application folder for completeness. **Failure to communicate with assigned advisor can delay your start date**. Advisors may be contacted by phone or e-mail.

Application folders are not automatically submitted to the Admissions Committee; the student must meet with their assigned Nursing Faculty Advisor and request submission.

2. COMPLETION OF ENC 1101 (COMPOSITION I).

A minimum grade of "C" or higher must be achieved prior to the desired application deadline.

3. COMPLETION OF BSC 2085 & BSC 2085L (ANATOMY & PHYSIOLOGY I WITH LAB). A minimum grade of "C" or higher must be achieved <u>prior</u> to the desired application deadline.

4. COMPLETION OF MATH REQUIREMENT

Completion of a 3-credit math course with the prefix MAC, MGF, or STA with a minimum grade of "C" must be achieved prior to the desired application deadline.

<u>NOTE</u>: Students who desire to <u>improve their probability of program selection and success</u> in ALL NURSING COURSES are encouraged to enroll in <u>MTB 1370 – Math for Health-Related Professions</u> and <u>HSC 1531 - Medical Terminology</u>. These courses are designed to improve understanding of core nursing concepts, not to reduce the length or number of credits in the Nursing Program.

- 5. TOTAL, OVERALL, UNDERGRADUATE, COLLEGE CREDIT (INCLUDING TRANSFER CREDITS) GRADE POINT AVERAGE (GPA) OF 2.5 (MINIMUM)
- 6. COMPLETION OF ATI TEAS 7 ADMISSION ASSESSMENT TEST / GCSC NURSING PROGRAM RECEIPT OF OFFICIAL TEAS SCORES (see last section, page 13)
 - Applicants must successfully complete the TEAS 7 Pre-Admission Exam (The Test of Essential Academic Skills)

This is exam is specifically designed to assess the academic preparedness of prospective students entering health science fields.

- <u>The TEAS 7 Exam may be taken no more than twice per selection period.</u> Selection periods are defined as October 1 through the end of February, and March 1 through the end of September. Scores are valid for a period of 2 years. The most recent score will be used for admissions.
- Beginning Fall 2025, students with overall scores below 66%, must obtain a certificate of completion in a 6-week ATI Launch Academic Readiness course prior to enrollment in NUR 1022C for first semester nursing program courses. The student will be responsible for the \$250 course fee.
- Included in this packet is information on the exam, the study guide, and how to register to take the exam.

<u>ADMISSION APPLICATION DEADLINES</u>: Two classes are admitted each year, one in spring and one in fall. The initial deadlines for application to be complete (with all checklist requirements completed) are by the last working day in **FEBRUARY** (for fall class) and the last working day in **SEPTEMBER** (for spring class).

<u>Advanced Placement:</u> This option is for the student who has completed any portion of a Registered Nursing Program's core courses at another college or University. Applicants will be considered for acceptance contingent upon successful completion of the Advanced Placement checklist (in addition to this application). Students' application folders will be considered at the last nursing faculty meeting of each semester, and maybe based on the set availability.

NOTE TO ALL STUDENTS: Admission to the program is <u>competitive in nature</u> and <u>is not guaranteed</u>. A selection committee ranks all applications and admission is granted to the most qualified applicants. Applicants can improve their chances of admission by maintaining a high GPA, completing pre & co-requisite courses and scoring high on the TEAS 7 entrance exam. It should be understood that satisfactorily meeting minimum requirements <u>does not</u> automatically guarantee admission.

<u>UPON ACCEPTANCE INTO THE NURSING PROGRAM</u>, THE FOLLOWING WILL BE REQUIRED:

- 1. CURRENT PPD or TB TEST or DECLINATION WITH X-RAY RESULTS
- 2. MEDICAL EXAMINATION With Satisfactory Results
- 3. SATISFACTORY FINGERPRINT / CRIMINAL BACKGROUND CHECK
- 4. **CURRENT CPR CARD** American Heart Association (BCLS-C) for Healthcare Provider (Basic Cardiac Life Support) is the only certification accepted.
- 5. **10-PANEL DRUG SCREENING** With Satisfactory Results

IMPORTANT INFORMATION REGARDING YOUR BACKGROUND

Applicants to the Nursing Programs in the Nursing Division of Gulf Coast State College work very hard to meet the entry requirements for selection. Our programs make every effort to accept as many academically qualified students as possible. In addition to meeting basic entry requirements, however, applicants must also consider how their personal history and background may affect their ability to meet admission and clinical requirements, sit for various state licensure exams, and ultimately gain employment.

CRIMINAL BACKGROUND CHECKS:

Gulf Coast State College (GCSC) students that are granted conditional acceptance into a Nursing program must receive a satisfactory criminal background check prior to final acceptance into the program. The background check will be scheduled and performed at the discretion of the Division to which the student has applied. Information and instructions on how to complete the background check will be sent by the applicable program coordinator.

Please Note: Criminal background checks performed through other agencies will not be accepted. Also, be aware that clinical agencies may require an additional background check prior to clinical access. Although background checks are required before program entry, it is possible to graduate from a program at GCSC and be denied the opportunity for licensure because of an unfavorable background check. Even if the student has been accepted into and completed a program at GCSC, this does not guarantee authorization for licensure or eligibility to take the licensure exam. Those authorizations are granted by the Nursing governing professional licensure boards. This is a notification to the applicant that Gulf Coast State College has no authority over any state-level medical licensure board and cannot be held responsible if the student is accepted into or completes a Nursing program and subsequently is denied authorization to take the program-specific licensure exam due to criminal background information.

An applicant must consider how his/her personal history may affect the ability to meet clinical requirements, sit for various licensure exams, and ultimately gain employment. Most healthcare boards in the State of Florida make decisions about licensure on an individual basis. You may visit the Florida Department of Health website at <u>https://www.floridahealth.gov/</u> for more information regarding licensure. We offer this information so that you can make an informed decision regarding your future.

<u>Please read the following information carefully</u>: Any student who has been found guilty of, regardless of adjudication, or entered a plea of nolo contendere, or guilty to, any offense under the provision of 456.0635 (see below) may be <u>disqualified</u> from admission to any Nursing program. In addition to these specific convictions, there are other crimes which may disqualify applicants from entering into the Nursing programs and/or clinical rotations. 456.0635 Health care fraud; disqualification for license, certificate, or registration. -

(1) Healthcare fraud in the practice of a healthcare professional is prohibited.

(2) Each board within the jurisdiction of the department, or the department if there is no board, shall refuse to admit a candidate to any examination and refuse to issue a license, certificate, or registration to any applicant if the candidate or applicant or any principal, officer, agent, managing employee, or affiliated person of the applicant:

(a) Has been convicted of, or entered a plea of guilty or nolo contendere to, regardless of adjudication, a felony under chapter 409, chapter 817, or chapter 893, or a similar felony offense committed in another state or jurisdiction, unless the candidate or applicant has successfully completed a drug court program for that felony and provides proof that the plea has been withdrawn or the charges have been dismissed.

Any such conviction or plea shall exclude the applicant or candidate from licensure, examination, certification, or registration unless the sentence and any subsequent period of probation for such conviction or plea ended:

1. For felonies of the first or second degree, more than 15 years before the date of application.

2. For felonies of the third degree, more than 10 years before the date of application, except for felonies of the third degree under s. $\underline{893.13}(6)(a)$.

3. For felonies of the third degree under s. <u>893.13(6)(a)</u>, more than 5 years before the date of application;

(b) Has been convicted of, or entered a plea of guilty or nolo contendere to, regardless of adjudication, a felony under 21 U.S.C. ss. 801-970, or 42 U.S.C. ss. 1395-1396, unless the sentence and any subsequent period of probation for such conviction or plea ended more than 15 years before the date of the application;

(c) Has been terminated for cause from the Florida Medicaid program pursuant to s. <u>409.913</u>, unless the candidate or applicant has been in good standing with the Florida Medicaid program for the most recent 5 years;

(d) Has been terminated for cause, pursuant to the appeals procedures established by the state, from any other state Medicaid program, unless the candidate or applicant has been in good standing with a state Medicaid program for the most recent 5 years and the termination occurred at least 20 years before the date of the application; or

(e) Is currently listed on the United States Department of Health and Human Services Office of Inspector General's List of Excluded Individuals and Entities, except when such applicant is listed solely based on a default or delinquency on a student loan as provided in s. <u>120.82</u>.

This subsection does not apply to an applicant for initial licensure, certification, or registration who was arrested or charged with a felony specified in paragraph (a) or paragraph (b) before July 1, 2009.

(3) The department shall refuse to renew a license, certificate, or registration of any applicant if the applicant or any principal, officer, agent, managing employee, or affiliated person of the applicant:

(a) Has been convicted of, or entered a plea of guilty or nolo contendere to, regardless of adjudication, a felony under chapter 409, chapter 817, or chapter 893, or a similar felony offense committed in another state or jurisdiction, unless the applicant is currently enrolled in a pretrial diversion or drug court program that allows the withdrawal of the plea for that felony upon successful completion of that program. Any such conviction or plea excludes the applicant from licensure renewal unless the sentence and any subsequent period of probation for such conviction or plea ended:

1. For felonies of the first or second degree, more than 15 years before the date of application.

2. For felonies of the third degree, more than 10 years before the date of application, except for felonies of the third degree under s. $\underline{893.13}(6)(a)$.

3. For felonies of the third degree under s. <u>893.13(6)(a)</u>, more than 5 years before the date of application.

(b) Has been convicted of, or entered a plea of guilty or nolo contendere to, regardless of adjudication, a felony under 21 U.S.C. ss. 801-970, or 42 U.S.C. ss. 1395-1396 since July 1, 2009, unless the sentence and any subsequent period of probation for such conviction or plea ended more than 15 years before the date of the application.

(c) Has been terminated for cause from the Florida Medicaid program pursuant to s. <u>409.913</u>, unless the applicant has been in good standing with the Florida Medicaid program for the most recent 5 years.

(d) Has been terminated for cause, pursuant to the appeals procedures established by the state, from any other state Medicaid program, unless the applicant has been in good standing with a state Medicaid program for the most recent 5 years and the termination occurred at least 20 years before the date of the application.

(e) Is currently listed on the United States Department of Health and Human Services Office of Inspector General's List of Excluded Individuals and Entities, except when such applicant is listed solely based on a default or delinquency on a student loan as provided in s. <u>120.82</u>.

This subsection does not apply to an applicant for renewal of licensure, certification, or registration who was arrested or charged with a felony specified in paragraph (a) or paragraph (b) before July 1, 2009.

(4) Licensed health care practitioners shall report allegations of health care fraud to the department, regardless of the practice setting in which the alleged health care fraud occurred.

(5) The acceptance by a licensing authority of a licensee's relinquishment of a license which is offered in response to or anticipation of the filing of administrative charges alleging health care fraud or similar charges constitutes the permanent revocation of the license.

Important Note: After acceptance and during enrollment in this program, the student is responsible for notifying the Program Coordinator of any arrest, regardless of adjudication, that occurs after acceptance through graduation. Failure to promptly notify the Program Coordinator shall be grounds for dismissal from the program.

Individuals who are considering entering the nursing profession and who have a criminal history often ask about potential barriers to licensure following successful completion of an approved nursing program. While it would be nice to know this prior to making a decision to enter the program, obtaining that information is not possible under current Florida law.

The Board of Nursing makes decisions about licensure based upon a number of questions on the application and on an individual basis. The application (or the background screening) that indicates a criminal history is considered a <u>non-routine application</u> and must be reviewed by the board staff and possibly referred to the Board of Nursing for action.

Each application is reviewed on its own merit. The Board of Nursing has created guidelines for specific offenses to be cleared in the board office; however, <u>the staff cannot make determinations in advance as laws and rules change over time</u>. Applications that involve violent crimes and repeat offenses are required to be presented to the Board of Nursing for review. Evidence of rehabilitation is important to the Board Members when making licensure decisions.

The Board may issue a license under conditions such as placing the license on probation with supervision, requiring additional education, or the Board may deny your application. If drugs or alcohol are a concern, the board may require the applicant to undergo an evaluation and possibly to sign a contract with the Intervention Project for Nurses (800-840-2720).

Each nursing program makes independent decisions about admissions into the program and may require a criminal background screening as part of that process. Clinical facilities may limit or prohibit students with criminal histories from participating in clinical experiences. Other options may not exist for students to complete the required clinical hours in order to obtain a nursing degree; therefore making such a student ineligible for licensure in Florida.

The licensure application requires disclosure of any criminal history and the disposition of all cases prior to board review. Entry into the nursing education program is the prospective student's decision based upon the knowledge that he/she may, or may not, be granted a nursing license. All of the above factors should be taken into consideration prior to making a decision about a nursing career.

Important Notice for Initial Licensure Applicants and Renewals:

Pursuant to <u>Section 456.0635</u>, Florida Statutes, you are being notified that effective July 1, 2012, health care boards or the department shall refuse to renew a license, certificate or registration, issue a license, certificate or registration and shall refuse to admit a candidate for examination if the applicant has been:

- Convicted or plead guilty or nolo contendre, regardless of adjudication, to a felony violation of: chapters <u>409</u>, <u>817</u>, or <u>893</u>, Florida Statutes; or <u>21 U.S.C. ss. 801-970</u> or <u>42 U.S.C. ss 1395-1396</u>, or similar offenses in other state. <u>unless the sentence and any probation or pleas ended more</u> <u>than 15 years prior to the application for 1st and 2nd degree felony; 10 years prior to the application for 3rd degree felony; and 5 years prior to the application for 3rd degree felony under Section <u>893.13(6)(a).</u>

- 2. Terminated for cause from Florida Medicaid Program (unless the applicant has been in good standing for the most recent 5 years).
- Terminated for cause by any other State Medicaid Program or the Medicare Program (unless the termination was at least 20 years prior to the date of the application and the applicant has been in good standing with the program for the most recent 5 years).

The Florida Board of Nursing receives numerous questions from applicants regarding prior criminal offenses. The following are the most frequently asked questions:

All convictions, guilty pleas and nolo contendere pleas must be reported, except for minor traffic violations not related to the use of drugs or alcohol. This includes misdemeanors, felonies, "driving while intoxicated (DWI)" and "driving under the influence "(DUI)." Crimes must be reported even if they are a suspended sentence. | | |

- Note: The burden of proof lies with the applicant to demonstrate evidence of positive lifestyle changes. Examples include, but are not limited to:
 - Documented evidence of professional treatment and counseling you have completed. Provide a discharge summary, if available.
 - Letters of professional recommendation on official letterhead from employers, nursing program administrators, nursing instructors, health professionals, professional counselors, support group sponsors, parole or probation officers, or other individuals in positions of authority.
 - Proof of community service, education and self-improvement.
 - Court-issued certificate(s) of expungement, proof of compliance with criminal probation or parole.

Applicants with previous arrest(s) or disciplinary action on a license will not be authorized to practice nursing until all documentation is cleared by staff or reviewed by the Board.

TEAS TEST REGISTRATION INFORMATION

- <u>Step # 1</u>: Pay for your exam at the Business Office window on the first floor of the Administration Building.
 - Inform them you are paying for the TEAS Pre-Admission Test. You may pay for the exam fee with cash, check, or credit card. (\$70 for current GCSC students or \$100 for non-GCSC students.)
 - The Business Office will give you two copies of your transaction receipt.
- <u>Step # 2</u>: To receive your testing date; bring one receipt to the Senior Administrative Assistant's office located in the Health Sciences building on the second floor, Room 229. You will be required to present the other receipt to the Testing Center on the day of your exam.
- <u>Step # 3</u>: Create an ATI Student Account: The directions on <u>How to Create a NEW ATI</u> <u>Account for TEAS at Institution Exams</u> are located outside of Health Sciences, Room 229 (on the left side).
- <u>Step # 4</u>: Exam Preparation: ATI offers a variety of test preparation options, ranging from a free TEAS Test Prep Mobile App to a comprehensive online study package with a GCSC discount code (see handout outside of Health Sciences, Room 229 for further information).

IMPORTANT INFORMATION

Students <u>must register</u> with the Senior Administrative Assistant (Health Sciences, Room 229) after paying for the TEAS EXAM to secure their seat for an exam date.

- The Testing Center is located in Student Union West, Room 80.
- Students should arrive at the testing site thirty (30) minutes before the scheduled testing time.
- You MUST bring a copy of your exam receipt and current photo ID to the Testing Center.
- If you cannot take the exam at the scheduled time, please notify the Testing Center and the Senior Administrative Assistant, Lisa Tyus, at 850.872.3829. You will need to reschedule your exam through Register Blast.
- The TEAS TEST may NOT be taken any <u>more than twice per selection period</u>. Selection periods are defined as October 1 through the end of the last working day of February, and March 1 through the end of the last working day of September.
- The most recent TEAS TEST score will be considered for admission.

If you are a student with a disability and wish to apply for accommodations for the TEAS TEST, you must contact the GCSC Student Accessibility Resources (SAR) Office at 850.747.3243 or email <u>sar@gulfcoast.edu</u> to inquire about the accommodation process at least 2 weeks prior to your intended test date.

STUDENTS WHO HAVE TAKEN THE TEAS TEST AT OTHER INSTITUTIONS:

Students may transfer TEAS exam scores taken at another institution or testing center, you must log into your ATI Student Account and send/manage your transcripts under the MY RESULTS TAB. TEAS test scores are considered valid within 2 years of the application deadline.

After completion of the exam, your test results will be sent electronically to the e-mail you provided when you created your ATI testing account. The official copy of the results will be forwarded to the Nursing program.

TEAS TEST SCHEDULE 2024-2025

Applicants to the Associate Degree Nursing program must complete a computer-based entrance exam called the TEAS TEST. It is comprised of exams to assess the academic and personal readiness of prospective students for higher education.

The test includes Reading, Mathematics (numbers and algebra, measurement, and data, Sciences (Human Anatomy & Physiology, Biology, Chemistry Scientific Reasoning), and English and Language usage. Question types include multiple choice, multiple select (select all that apply) fill-in-the-blank, ordered response, and hot spots. Students are encouraged to prepare for this examination.
